Digital Single Riser Output Module

Features

- During normal standby, Output port (O1, O2) is provided with Class B pathway supervision when connects with 47KΩ EOLR (Part Number 30108524).
- Occupying one address. It can be modified in filed.
- Output port utilizes AD sampling technology for precise testing.
- ♦ Guide rail for installation, easy for construction.
- Compatible with GST-M200 and GST-IFP4M Fire Alarm Control Panels (FACP).
- ♦ Standard: UL864, NFPA [70, 72].

Description

With a microprocessor, DI-M9305 Digital Single Riser Output Module can communicate with a FACP. The module is designed to switch on/off 24VDC power at its output.

Connection and Cabling

Fig. 1 shows terminals on the module.



- (Z1, Z2) IN & OUT: Connecting with loop of FACP, polarity-insensitive.
- (I1, I2) IN & OUT: Power input terminals. For connecting with 24VDC power from Listed FACP or power supply.
- O1, O2: Output terminals to 24VDC powered devices CODE: connecting with P-9910B programmer.

Recommended Wiring

17 AWG or above fire cable for all terminals, and subject to local codes.



Installation

Warning:

Before installing the module, disconnect power from the loop and verify that the guide rail is securely installed.

- Before installation, make sure the enclosure is in good condition and markings are complete.
- 2) The module shall either be installed in a North America standard metal electrical box. Minimum size is 4 in. square, 2-1/8 in depth (in this case, standard box cover is required), or in a UL Signaling Listed enclosure that provides minimum wiring entries and spacing as shown on Fig 2 and Fig 3. Minimum mounting space is 67x40.5mm.
- 3) The module can be mounted on a guide rail as shown on Fig 4.
- 4) The module can also be installed in the enclosure by 4 mounting screws as shown in Fig.5.









Application

The module is designed to switch on/off connection between I1/I2 and O1/O2. The address can be programmed in field through a P-9910B Hand Held Programmer.

Programming Parameters:

In standby state of the programmer, pressing *Fn* and then number 3, "—" (data waiting for programming) will be popped up on the screen. Writing a parameter and then pressing "*Program*", a "P" will show on the screen meaning the parameter is programmed.

Parameters used for O1/O2 setting includes:

Any other numbers(Default)	Checking

The system connection is shown in Fig. 6.


